## **Public Hearings**

 Special Use Permit (Petition No. 15U-001) request from Emily Ewing for Pet Care Services in an HM-MU District located at 9057 Selborne Lane.
 Mr. Merrill read the rules for the public hearing and opened the public hearing.

Emily Ewing, applicant, presented her request to operate a Pet Care services business at 9057 Selborne Lane. She said that her proposed pet grooming and doggy daycare business would fill void in the community. She currently is operating a retail pet supplies shop on the street level portion and the lower floor would house the grooming and daycare. The business will accommodate no more than ten dogs at a time, dogs would be temperament tested, and noise reducing curtains would be used.
